BW/076/15 County Councillors Report.

 Williams Commission recommended that PCC and Powys Teaching Health Board develop a closer working relationship with the integration of a number of services. This work is being developed and the Welsh Government has agreed to fund some of this work.

- Here in Builth Wells we have benefitted from joint working with the building and provision of Glan Irfon which offers health and adult social care services.
- PCC has awarded the contract of running all its leisure centres to Freedom Leisure² There was limited press announcement to this change as it occurred during the General Election period and PCC was in a legal gap called 'purdah'³, (prohibits the publication by local authorities of material which in whole or in part appears to be designed to affect public support for a political party).
- At the PCC stand at the RWAS, PCC will be trialling a 'budget simulator' to allow people to insert their ideas for necessary expenditure or savings and see straight away how it will affect the overall budget.
- Cllr York reported that due to the volume of complaints about 'fly tipping' at the recycling area at the Co-Op, Brecon Road, she is trying to persuade PCC to close it down. Apart from the skip for cardboard, all other items are collected at kerb side, so she has suggested moving this facility to Smithfield alongside the garden waste receptacles.
- **Cllr L.Jones** raised the issue of needing more green bins to accommodate the amount being left outside them.

Cllr York stated that she was receiving many complaints about this and is always asking for them to be emptied more frequently, but it is the style of bins being used that appears to be the main problem.

- Cllr York reported that she had nominated Elin Non Ennis of Builth High School and, Richard Jones of the Irfon Judo Club for Red Kite awards in recognition of their services to the community. These awards have now taken place.
- **Cllr M.Prynne**, There is a large fence running adjacent to Hospital Road and next to Erris Villa, the property of Mr M Coyle. It is falling over and is owned by PCC. **CC A.York**, agreed to look into the matter.
