#### **BW/095/15** Clerks report from Minutes

Outstanding matter of Superfast Cymru box location outside Wyeside, meeting, now covered under County Councillors report.

#### **BW/096/15 County Councillors Report**

Business rates relief for those under a rateable value of £50,000 will attract a £1500 discount.

The Government has announced a  $\pm 50$  million pound cut to Wales budget. It will be inevitable that Powys will attract even more cuts.

County Councillor York will be attending a meeting in relation to the siting of a Superfast broadband box. She will be accompanied by Cllr Price who has

considerable knowledge in this field, which she welcomed. An update to the Council will be given. Cllr York emphasised the support and commitment of the trustees of the Wyeside for Builth Wells High Street to have these facilities. She highlighted that the building is Grade Two listed and all possibilities needed to be explored, not necessarily the one wanted by a private company.

Cllr Price reiterated his interest in obtaining the software used by PCC to calculate their projected figures of pupil loss. As on the Welsh Assembly site they are stating that the loss of pupils (11-18yrs) to 2035 shows only a drop of 3.8%. Cllr York reminded that **today**, across Powys, we have 1500 vacancies. The problem of today should have been sorted years earlier, however she will look into the point he raises.

Cllr Wellstead ask for a copy of the previous independent reports relating to the above, a matter Cllr York would look into.

Cllr A Jones raised the issue of the Groe trees and in particular the tree with a fish carved into it. It is now becoming in a dangerous condition, it was this council's belief that the tree surgeon had been given instructions some time ago, to fell the tree and give the carving to Builth Town Council. Cllr York to look into the matter.

Cllr Reardon (Chairman) extended to County Councillor A. York an open invitation to remain throughout all of the meetings and where applicable may be able to contribute to specific matters within her knowledge.

#### BW/099/15 Summer Flower Baskets, update

Cllr D.Jones (through Clerk) reported that 111 baskets and one tub were successfully arranged and hung. He extended his thanks to all that helped on the day.

#### BW/100/15 Builth Wells Town Council Garden Competition.

Cllr D Jones (through Clerk) reported that there had been a small increase in competitors 2015 but that the Garden Club at their AGM decided that as no persons attended the prize giving event for two years, they were no longer supporting the event. Following further discussions it was **Proposed/Seconded/Resolved,** Cllrs Reardon/Price that the competition be discontinued.

#### BW/101/15 Groe area and dogs under control.

The Council considered the best time to being the spray and shame campaign. At present the area needed to have the grass cut and the effectiveness of spraying would be lost. It is hoped that this campaign will start soon subject to PCC grass maintenance program. The Council was also informed of an incident involving violent behaviour towards a member of the community who challenged an irresponsible dog owner. The Council are concerned that this issue is a Powys wide problem that requires official recognition to be dealt with properly. It was **Proposed/Seconded/Resolved**, by Cllrs Prynne/A.Richards that the Clerk write to Christopher Salmon, Police & Crime Commissioner, Dyfed Powys seeking his commitment to this problem and to explore the possibilities of PCSO's having further powers to deal with offenders.

#### BW/102/15 Welsh Water, Traffic noise on Brecon Road.

Cllr L.Jones (through Clerk) reported that she had contacted Welsh Water who were apologetic and gave an undertaking that even when emergency repairs are needed, lorry movement would not occur between 12 midnight and 5am.

It was reported that the first meeting and introductions were informative and positive. The next meeting will be Thursday 11<sup>th</sup> in the Strand Hall. Further report next month.

Authority has been granted for Cllr.A.Jones to purchase a 'gazebo' and councillors gave an undertaking to help throughout the day, subject to other commitments whilst they were there. **Proposed/Seconded/Resolved,** Cllrs Chard/A.Richards that Cllr A.Jones purchase a 'gazebo' for this and other council events.

'The Welsh Government is supportive in principle of the revenue and capital funding proposals which have been submitted to them. Officials are currently considering them in line with Welsh Government procedures and we should receive a response in the next week or two.'
